WHEREAS By-law 720-122 entitled "By-law modifying Zoning By-law 720 in order to modify provisions regarding residual space of built landsite, to authorize ancillary uses and structures for the "Commercial" group of uses, to modify the definition of a tree and the limits of zones INST-325 and P-326" was adopted at the regular Council meeting on Monday, October 24, 2022;

WHEREAS By-law 720-122 entitled "By-law modifying Zoning By-law 720 in order to modify provisions regarding residual space of built landsite, to authorize ancillary uses and structures for the "Commercial" group of uses, to modify the definition of a tree and the limits of zones INST-325 and P-326" was withheld approval at the regular meeting of the Executive Committee of the City of Montreal on Wednesday, December 14 by resolution CE22 2128;
