BY-LAW BEAC-166 BY-LAW AUTHORIZING A LOAN OF \$844,270 FOR THE REHABILITATION WORK OF THE PEDESTRIAN BRIDGE ABOVE AUTOROUTE 20

At the regular meeting of the Municipal Council of the City of Beaconsfield, held at City Hall, 303 Beaconsfield Boulevard, Beaconsfield, Quebec, on Monday, XXX XX, 2025, at 8 p.m.

WERE PRESENT: His Honour the Mayor Georges Bourelle, Councillors Dominique Godin, Martin St-Jean, Robert Mercuri, David Newell, Roger Moss and Peggy Alexopoulos

WHEREAS the City of Beaconsfield is applying section 556 of the Cities and Towns Act;

WHEREAS this by-law requires only the approval of the Minister and does not require the approval of the qualified voters since the following conditions meet the requirements of section 556 of the *Cities and Towns Act*: (1) the object of the by-law is to carry out road construction, drinking water supply and waste water disposal work and (2) the repayment of the loan is entirely borne by the owners of immovables in the entire territory of the municipality;

WHEREAS the loan under this by-law is decreed for the purpose of capital expenditures relating to an object provided for in the Capital Expenditure Program of the City;

WHEREAS notice of motion of the present by-law was given at the regular Council meeting held on XXXXX XX 2025;

On motion of Councillor XXX, seconded by XXX and UNANIMOUSLY RESOLVED:

THE COUNCIL OF THE CITY OF BEACONSFIELD ENACTS THE FOLLOWING:

- <u>SECTION 1</u>: Council is authorized to carry out or to have carried out works related to the rehabilitation work of the pedestrian bridge above Autoroute 20, as per the detailed estimates of the work costs prepared by Dany lannantuoni ing. Director of Public Works and Ahmed Merheb, Section Head projects, dated January 9, 2025, the whole as described in annexes A and B of this by-law.
- <u>SECTION 2</u>: Council is authorized to spend an amount of \$844,270 which includes fees, taxes and other related expenses and contingencies.
- <u>SECTION 3</u>: In order to pay for the expenses provided by this by-law, Council is authorized to borrow an amount of \$844,270 for a term of twenty-five (25) years.
- <u>SECTION 4</u>: Council shall annually appropriate, during the term of the loan, a portion of the municipality's general revenues to provide for expenses incurred for interests and the reimbursement in capital of the loan's annual maturities, the whole in accordance with section 547 of the *Cities and Towns Act*.
- <u>SECTION 5</u>: In the event that the amount of an allotment authorized by the present by-law is higher than the amount actually spent in relation with this allotment, Council is authorized to make use of this surplus to pay any other expense enacted by the present by-law and for which the allotment has become insufficient.
- <u>SECTION 6</u>: Council will allocate to the reduction of the loan authorized by this by-law, all contributions or grants that could be received for the payment of part or all of the expenditure enacted by the present by-law.
- <u>SECTION 7</u>: This by-law shall come into force according to law.
