The City Clerk announces the beginning of the public question period.

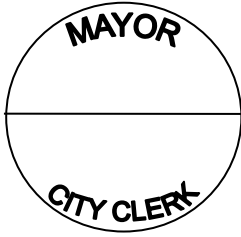
A resident asks if the proposed by-laws will only apply for short-term rentals on specific platforms or will they also apply to room rentals. He says that the rental of rooms in residence causes nuisance in a neighbourhood.

Ms. Mireille Gascon answers that the draft by-laws are not only for specific platforms but rather to establish provisions where short-term rentals are allowed in Beaconsfield and which requirements and documents are needed. Room rentals are already in the zoning by-law. Mayor Bourelle says that often, rentals that are not complying with our by-laws are known after a complain by a neighbour. Councillor Moss adds a comment regarding the owner or a representative.
