

Minutes of the City of Beaconsfield's regular Municipal Council meeting, held at City Hall, 303 Beaconsfield Boulevard, Beaconsfield, Québec, on Monday, February 26, 2024, at 8:00 p.m.

1. OPENING OF MEETING

Her Honour the Acting Mayor calls the meeting to order.

- 2. <u>AGENDA</u>
- 2.1 Adoption of the agenda of the City of Beaconsfield's regular Council meeting of February 26, 2024
- 2024-02-030 It is moved by Councillor Martin St-Jean, seconded by Councillor Roger Moss and UNANIMOUSLY RESOLVED to adopt the agenda of the City of Beaconsfield's regular Council meeting of February 26, 2024, as presented.
- 5. PUBLIC QUESTION PERIOD

The City Clerk announces the beginning of the public question period.

Her Honour the Acting Mayor, Councillor Dominique Godin explains the procedure to appoint an Acting Mayor in absence of the Mayor. She also describes the different communication tools that a resident can use to share concerns or to get the City's latest updates. Lastly, she informs the residents of the activities during school break and reminds the residents of the deadline for tax payment. Her Honour the Acting Mayor indicates the passing of two persons that have greatly participated in Beaconsfield's civic life. With respect, she underlines the contribution of Mr. John Parsons and Mr. John Gradwell.

A resident would like to know what measures are taken by the City to assure that the residents are adhering to the new by-law regarding the wood-burning fire places and stoves. He indicates that he has not noticed any change yet in the smoky air outside in his neighbourhood. He suggests that the by-law be replaced by a one that is stricter and enforceable.

Her Honour the Acting Mayor indicates that the City has not received any complaints and has not issued any notice of infraction to date. As mentioned at the last Council meeting, she indicates that if the resident is witnessing continuous burning in a neighbourhood, he should not hesitate to call Municipal Patrol.

A resident mentions that rodenticide has been used outside the Recreation Centre last year. She asks that the contractors only use organic pest control and non-lethal humane methods of rodent and wildlife management.

Her Honour the Acting Mayor thanks the resident for her comments and indicates that contractors must abide to municipal by-laws and provincial regulations. She also thanks the resident for her comments on trees and municipal dog pound in Beaconsfield.



A resident asks to get details on what is included in the mandate 23-SP-184 relating to the renovation work and upgrading of the Beaconsfield Recreation Centre. He also asks to explain why the loan by-law is \$125,303.2 more than mandate 23-SP-184 price for the preparation of plans and specifications. He asks how much more will be required to borrow to renovate and upgrade the Recreation Centre.

Her Honour the Acting Mayor asks Director general to answer the questions. Patrice Boileau indicates that the entire Recreation Centre needs renovation which includes the pool, the offices, restrooms, mainly architecture and mechanical components for 2 extensions, in 3 phases, over 4 to 5 years. He adds that the City has applied for a Government grant, PAFIRSPA (Programme d'aide financière aux infrastructures récréatives, sportives et de plein air), the answer from the Government should be received this summer. He then explains that the amount is for a consultant. He indicates that the City has chosen a management method based on the "integrated project management team" model requiring planning and a very strict monitoring of the design and support during the renovation. The City is also planning a special Council meeting on March 11 for the adoption of the by-law. Finally, he indicates that the City does not know yet how much it will need to borrow as it needs to find out first, how much will be received from the grant.

A resident indicates that the site where the barn was demolished is exposed to several chemicals, petroleum and paint, she would like to know if the soil has been tested for contamination and if decontamination needs to be done, will this amount be added to the project's cost.

Her Honour the Acting Mayor asks Director general to answer the questions. Patrice Boileau indicates that 5 samples were taken a few years ago, the test revealed that there is no problem with the quality of the soil. He then indicates that eventually the soil below the barn will need to be tested. He adds that the concern for contamination is very low. He indicates that if any decontamination needs to be done, the City will pay.

A resident congratulates Her Honour the Acting Mayor for chairing the meeting. He explains that an artificial ice rink would be perfect at the tennis court near where the barn used to be. He suggests that the Cities from Sainte-Anne de Bellevue to Dorval could share the cost so hockey can be played all year around.

Her Honour the Acting Mayor indicates that an architectural competition is being held for that space at the moment. She adds that she appreciates his idea and comments.

A resident asks if mandate 23-SP-184 is really only for the preparation of plans and specifications. She asks how much the execution of the project will cost. She also asks if demolishing would be a better option.

Her Honour the Acting Mayor asks Director general to answer the questions. Patrice Boileau indicates that usually plans and specifications cover 10 to 15 % of the total amount of a project. He explains that this is a huge project, that it includes 2 extensions, redoing the pool, adding a family room, creating adequate office space for the employees, adding sprinklers and emergency exists which need to be up to the standards of the Building Code requirements. He appreciates the question on demolition, he adds that a new project of this nature costs around 75 million. He explains that for the purpose of the renovation, different services will not be available to the residents, it will be done in sequences. He indicates that an answer concerning the grant should be received by June.
