Good evening everyone, Bonsoir à tous,

It is with deep emotion that I speak to you tonight.

After three terms serving the community of Beaconsfield with dedication and purpose, the time has come for me to turn an important page in my life. This fall, I will complete my mandate as Mayor, and with that, bring my political career to a close.

This was not an easy decision. I thought about it long and hard, weighing my personal priorities, my values, and the evolving needs of our community. Being Mayor of Beaconsfield has been one of the most demanding, meaningful, and fulfilling commitments of my life

Since 2013, in addition to my role as Mayor, I have had the honour of representing our City at the Montreal Agglomeration table: as a member and then Vice-Chair of the Finance Commission, as Vice-Chair of the Inspector General Commission, and as member of the Commission on Economic and Urban Development and member of the Board of the Société de transport de Montréal. These responsibilities allowed me to defend our interests regionally, and to do so with conviction and persistence.

Over these twelve years, we have gone through challenges together, but also many successes. We have invested in the future of Beaconsfield while protecting the quality of life that makes our City so special.

Je suis particulièrement fier de la manière dont nous avons géré nos finances publiques. En douze ans, l'inflation a augmenté de 32,6 %, tandis que notre contribution aux services régionaux de l'agglomération a augmenté de 58,34 %, sans que nous bénéficiions de services supplémentaires. Malgré cela, nous avons limité la hausse des taxes locales à seulement 19,41 %. En



réalité, nous avons réduit la charge fiscale réelle de 13,5 % par rapport à l'inflation. C'est remarquable.

Dès le premier jour, j'ai promis de protéger le bois Angell. Après des décennies de débats, nous y sommes finalement parvenus. Cette protection a permis de créer l'un des plus grands espaces naturels publics de l'île de Montréal qui sera accessible aux générations futures.

In 2016, we introduced incentive-based waste collection. Since then, we have cut our landfill tonnage in half, which is a major step for the environment.

We also invested in our infrastructure. We have expanded and renovated our Recreation Centre and rebuilt the arena which will open in June. We have upgraded the Beacon Hill and Shannon chalets, replaced park equipment, and ensured proper maintenance of our streets, water and sewer pipes across the board. Infrastructure work isn't glamorous, as it often causes disruptions, but it is essential to preserving our services and quality of life

We took action to improve safety on our streets by adding trafficcalming measures and bike paths. We also corrected a major error by the provincial government that had wrongly placed nearly all waterfront homes into flood zones. We defended our citizens, protected the value of their properties, and won.

Nous avons élaboré une vision commune à long terme pour Beaconsfield avec nos bénévoles et nos organismes communautaires. Le fruit de cette démarche collaborative est le projet Imaginons Centennial. Ce projet transformera notre bord de l'eau et le parc Centennial en un espace dynamique, inclusif et moderne dédié aux loisirs et à la vie communautaire. C'est un legs dont je suis fier.

Je suis également très fier de vous annoncer que la conception de ce future centre culturel multifonctionnel, réalisée par la firme Lemay, a reçu la médaille d'or aux 2024 World Architecture News Awards, dans la très compétitive catégorie « Future Projects ». Il s'agit d'une reconnaissance mondiale pour un projet imaginé ici, chez nous, pour notre communauté.

But there is one battle that has defined my time in office more than any other.

In 2020, the City of Montreal imposed a 10% increase on our contribution for regional services such as police, fire, transit, and water, despite inflation being just 2% and with no additional services to show for it.

I could not accept this injustice. Beaconsfield was the only city to stand up and take the matter to court. It was not a popular move among the other mayors. But it was the right thing to do. Had they supported our first legal challenge back in 2020, their combined claim today would exceed 120 million dollars. Our own claim now exceeds 20 million dollars.

This system is fundamentally undemocratic. Montreal decides the amounts. It votes alone to approve them. Then we, the demerged cities, receive the bill without negotiation, without recourse, without true representation. Even if all 15 of us oppose the decision, it makes no difference. We still have to pay.

This is not how democracy is supposed to work.

Our legal challenge is ongoing. More recently, a new regional expense emerged, and this time, all the other cities decided to join



in a joint legal action.

From the beginning of my mandate, I also made it a priority to restore respect and order to our Council meetings. We had come out of a period of tension and conflict. I wanted a space where ideas could be exchanged openly, but always respectfully.

To those who choose to enter public life: I salute your courage. In this age of social media, disinformation, and personal attacks, political engagement is more difficult, but also more necessary, than ever.

It remains a noble calling. It is a generous act of service. And it is deeply rewarding.

As I look back, I am filled with gratitude. I raised a family I am proud of. I had a long career in business. And I had the privilege of serving this community for twelve years. You trusted me with that honour three times, and I thank you from the bottom of my heart.

I leave politics with peace of mind, and with immense pride in what we have built together. I remain, as always, deeply committed to Beaconsfield.

The City Clerk announces the beginning of the public question period.

A resident asks, in relation to item 20.3 of the agenda, whether Zoom Communications is a Canadian company given the City voted to give priority to Canadian companies. The resident also inquires as to which company is currently used by the City. She also asks a question with regard to item 50.2, for an explanation of the Director General's working conditions.

His Honour the Mayor invite Mr. Patrice Boileau, Director General, to answer. Mr. Boileau, responds that Zoom is an American-based company, but that it has addresses in Europe, which could allow the City to do business with them. Nevertheless, in this case, the City is requesting that Council adopt a resolution to exceptionally allow the City to acquire an American software. The City must also pass a resolution of the Council, because the costs are above \$50,000 over a three-year period. Mr. Boileau also mentions that the prices of the other companies were twice what Zoom is asking. Mr. Boileau responds that the City currently does business with Calgah, and that the name of the system is Zultys. He notes that there are recurring problems with the telephone lines. With regard to the working conditions of the director general, his Honour the Mayor explains that the Director General will soon turn 65, and that the City would like to keep him on as Director General. For this reason, the City has drafted an agreement for approval by the Council this evening. The agreement provides that he



stays on in his position for three years, with a one-year option. He indicates that he will remain Director General and that he will help to prepare the transfer of leadership.

A resident makes comments about the public works personnel. He finds them to be expert, courteous, cautious, and attentive. He wishes to call attention to the blue collars, who he is concerned do not receive the attention they deserve and are sometimes even the objects of abuse.

His Honor the Mayor thanks the resident for his comments. Mr. Boileau thanks the resident and informs Council that this resident was one of the speakers for May Day. He notes that this is Public Works Week, that we appreciate the work that our blue collars do, and that they will be made aware of this appreciation for their work.

WHEREAS the collective framework agreements reached as part of the last joint call for tenders for the acquisition of clear diesel expire on January 31, 2026, with one last renewal option of one year;

WHEREAS, if the renewal option is not invoked, the City of Montreal wishes to participate in 2025 in the launch of a call for tenders led by the "Association du transport urbain du Québec (ATUQ)" to meet the clear diesel needs of the boroughs, related cities as well as corporate services for a 2-year period starting on February 1, 2026, or May 1, 2026;

WHEREAS in accordance with sections 572.1 and 573 of the *Cities and Towns Act* (CQLR, c. C-19), a municipality may unite with another municipality for the purpose of obtaining supplies and may mandate, while respecting the legal tender process;

It is moved by Councillor Peggy Alexopoulos, seconded by Councillor Martin St-Jean and UNANIMOUSLY RESOLVED that the City of Beaconsfield confirm its intent to participate in the group purchase by the City of Montreal relating to the supply of clear diesel upon confirmation by the City of Montreal;
